

Community Garden Sustainability Fund

Background Information

Since 2010, Grow Pittsburgh, Western Pennsylvania Conservancy, and Allegheny County Economic Development have been working together to start new food gardens through the City Growers and Allegheny Grows programs. This year, Grow Pittsburgh is also offering technical assistance and materials to support the efforts of *existing* community food gardens, through the Community Garden Sustainability Fund.

This fund is intended to assist existing community food gardens with projects that contribute to the productivity and sustainability of food growing at the garden. For instance, groups can apply for materials such as fencing, raised beds, compost and topsoil, rain barrels, and services like tilling or soil testing. Selected projects will be implemented in fall 2013.

Who is Eligible?

In order to be eligible for support, a community garden must have:

- 1) A minimum of 6 organized and motivated gardeners in the garden group
- 2) An already functioning community food garden
- *3)* Written permission by owner to tend to the designated location. *Preferred ownership by a non-profit or municipality. If privately owned, please provide proof of insurance and demonstrate how the garden is serving the public.*
- 4) Note: Current 2013 City Growers and Allegheny Grows participants are <u>not</u> eligible for this assistance. However, we do encourage the graduated gardens of these programs to apply.

Priority will be given to gardens that are working to increase the access to and availability of fresh, healthy food in their neighborhoods. Proposals up to \$2,000 will be considered, though **smaller projects will be more likely to receive funding.**
